I understand that discounted fares typically involve restrictions and that changing any aspect of my travel arrangements may result in the payment of additional money.

I understand that I may obtain information on travel insurance from Villas of Vallarta.com, L.L.C.

**Reservations:** All reservations require a 50% deposit of the entire rental fee at the time the reservations are made, including airline reservations, cruise reservations, car rentals and accommodations. Full payment is required 45 days before travel (60 days for Holidays). If there is a security deposit required, it will be collected on the final payment. Security deposits are refunded within 60 days after travel is complete. VISA, MasterCard, personal checks, and money orders are acceptable forms of payment.

**Cancellation Policy:** If your reservation is cancelled, Villas of Vallarta.com, L.L.C. provides refunds if, and only if, we can re-book the property for the identical travel dates and at the same rental rate. If the property remains vacant, no refund is issued. All cancellations will be assessed a \$150.00 processing charge regardless of any re-booking. Please realize that the earlier you cancel, the better chances are the property will be re-booked. If you cancel at the last minute, we will often cut the rental rate to attract a booking. If this happens, your refund will be deducted based the difference between the full rate and reduced rate and minus the \$150.00 processing charge. In most cases, last minute cancellations do not get re-booked in which case refunds will not be issued. Cancellation insurance is a great option to protect you and is available and may be purchased by speaking to one of our agents.
